## Organisations

The MSA GB has continued to be members of the Parliamentary Advisory Committee on Transport Safety (PACTS) and the Royal Society for the Prevention of Accidents (RoSPA).

MSA GB representatives have attended more meetings and seminars this year and have enjoyed meeting more instructors all around the country.

However, for convenience and to reduce our carbon footprint and costs, we have also continued to use our various digital platforms to help better interact with instructors.

## EFA

During the year under review, MSA GB has continued its membership of the European Driving Schools Association (EFA). Representatives from MSA GB attended delegate meetings on a virtual platform.

## National Associations Strategic Partnership (NASP)

The major driver trainer representative bodies have continued to collaborate through NASP to work on behalf of the profession and tackle the many complex issues affecting the driver training industry during the pandemic.

MSA GB takes its turn on a rotational basis to chair NASP and has worked closely with the DVSA, DfT and other Government bodies over the past year, ensuring members received up-to-date information on the current situation regarding issues within driver training and testing, particularly the lengthy L-test waiting times and consultations on pupils only booking driving tests.

During the year under review, DVSA have made very little difference to the waiting times for driving tests.

## Annual Conference

We decided to hold our AGM as a digital event then hold a 90th birthday celebration event in July.

The event was well attended in the Village Hotel in Coventry, with great speakers from DVSA, as well as a number of road safety and driver training experts.

All those who attended commented, it was a very informative event which offered great advice and networking and was an excellent way to celebrate our 90th year.

## Members' Insurance

MSA GB still holds Public Liability Insurance in the sum of £10,000,000 and Professional Indemnity insurance in the sum of £5,000,000 for the MSA GB and for MSA GB members engaged in any driver training that they are qualified to deliver.

The current policy is provided by Hiscox and expires on 29th June 2026; MSA GB will renew this policy on the due date or purchase a new policy with similar cover.

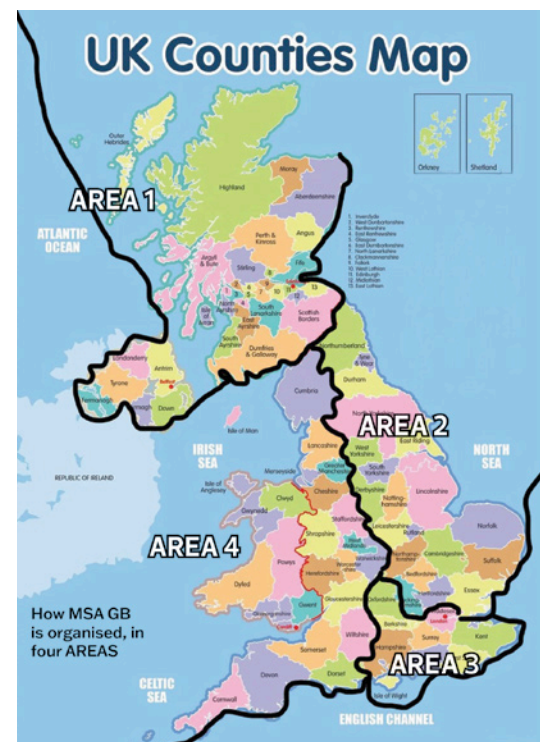

The directors are satisfied that the company is entitled to exemption from the requirement to obtain an audit under section 477 of the Companies Act 2006.

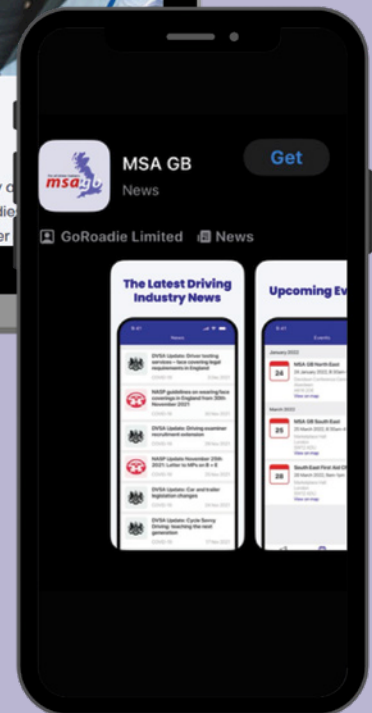
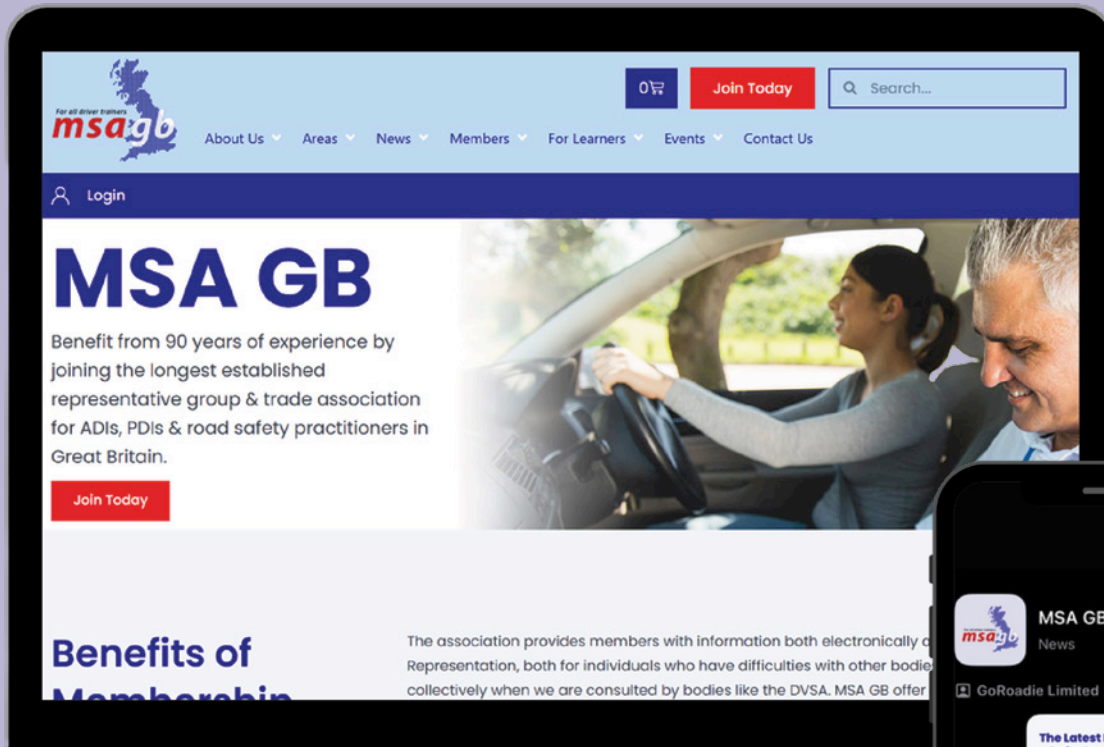
The members have not required the company to obtain an audit in accordance with section 476 of the Act.
